I. Welcome and Introductions

Moses Aguirre welcomed members and the meeting began at 10:07 a.m. Attendance was taken, followed by individual introductions by meeting participants. Moses informed the committee of new member, Muneet Chohan and welcomed committee guests, Cathy Galbraith and Britny Hawkins.

II. Minutes from Previous Meeting

Moses Aguirre directed attendees to the May 17, 2018 meeting minutes and requested attendees bring forth any changes. No changes were brought forward.

It was moved and seconded and the minutes from the May 17, 2018 meeting were unanimously approved.

III. Landscape Update

Kristie Griffin opened a discussion on talent acquisition and retention challenges related to the high cost of housing in California. Committee members engaged in dialogue on this topic and shared their experiences with similar problems in their regions. Committee members discussed the cost-of-housing challenges that are influencing staffing in their hospitals/systems. Committee members openly shared strategies for addressing these challenges. Kristie believes this needs to be a national discussion.

Anette Smith-Dohring then introduced the topic of BRN and their role in nursing displacement/alignment. Anette shared that the public community colleges have gone to the BRN to express their concerns. A roundtable discussion ensued and member shared their thoughts and experiences on this topic. There will be regional round tables throughout the state hosted by Health Impact where this issue will be discussed and strategies explored.

Anette also brought up student background checks and the need for the background checks to be recent, reminding other members that students' backgrounds can change over a 90-day period so be sure to have recent records on file when a student is on-boarded.

IV. Leaves of Absence Joint Sub-committee Report

Gail Blanchard-Saiger gave a brief introduction on the history and objectives of the Leaves of Absence Joint Sub-committee. Gail then gave a visual presentation on the LOA Sub-committee webpage that included a demonstration on navigating the page. Gail highlighted several available resources on the page and asked the group to share any valuable tools they wish to be included in the online LOA resource library. Gail went on to describe a Leaves of Absence Self-Assessment tool that is currently under development at CHA.

Cathy Martin presented an update on workforce and education legislation through the end of the legislative session. Cathy's update included a summary of the following bills:

- AB 2143 (Caballero): Licensed Health Service Provider Education Program- Vetoed
- AB 2202 (Gray): UC Merced Medical School-Signed by Governor
- AB 2281 (Irwin): Medical Laboratory Workforce Modernization-Signed by Governor
- AB 2539 (Mathis): Steve Thompson Loan Repayment Program-Held in Approps
- AB 2759 (Santiago): Baccalaureate vs. Associate Degree Nursing training and employment-Held
- SB 906 (Beall & Anderson): Peer Specialist Certification-Vetoed by Governor
- SB 1348 (Pan): Diversity and demographic reporting for allied health students-Signed by Governor
- SB 1373 (Stone): Pharmacist Ratios-Held
