Dear Public Health and Clinical Laboratory Directors:

We have very exciting changes to our personnel licensing online system (PERL).

Starting mid-June, Laboratory Field Services (LFS) will implement a new method to print licenses directly through the PERL system. We will no longer be mailing licenses once this change is implemented. Licensees and certificate holders will be able to download and print as many copies as needed, provided the license or certificate is active.

In addition, the downloadable license also features a new look that includes a QR code. When scanned on a smart phone camera the QR code provides direct access to the LFS personnel license verification website. The LFS personnel license verification website may be accessed without the QR code as well at:

https://www.cdph.ca.gov/Programs/OSPHLD/LFS/Pages/licensesearch.aspx.

An applicant approved after this change will receive an email with the license attached in PDF format. All applicants approved prior to this change will be able to print their licenses through the PERL system. Instructions on how to download and print their license can be found on our website.

Finally, this letter serves as a notice that you must accept licenses and certificates printed by laboratory personnel as an official document once this method is implemented. A sample of the new license is enclosed.


Sample of Laboratory Personnel Electronic License
