As hospitals are forced to make cuts or close outright (between January 2013 and February 2020, three rural hospitals in California closed and 13 are currently at risk of closure), patients are even further harmed.

Notes: Rural closures increase inpatient mortality by 8.7%; Medicaid patients and racial minorities are relatively worse affected by rural closures (11.3% and 12.6%, respectively)

Following rural hospital closures, **patients must go to nearby, already-overcrowded hospitals**. The distance patients must **travel to access basic inpatient services increases by 20 miles**; for specialty services like **treatment for substance use disorders, distance increases by almost 40 miles**.

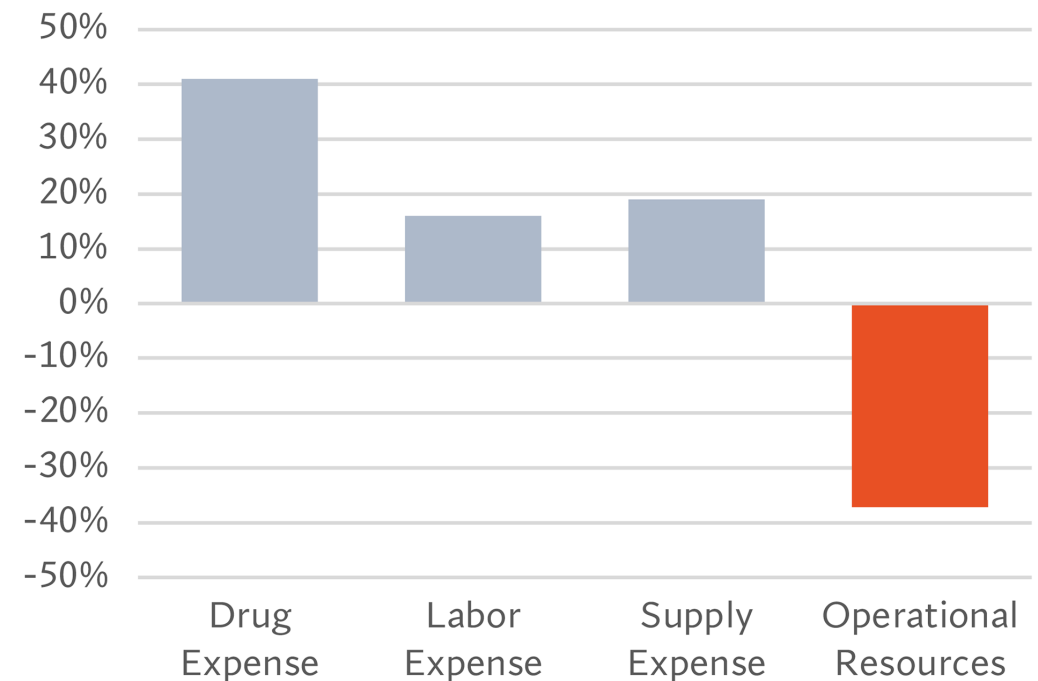
As expenses rise, resources to care for patients are falling short.

Inflation drains resources for patient care.

From 2019 to 2021:

- Labor expenses **rose 16%.**
- Pharmaceutical costs **grew by 41%.**
- Medical supply expenses **jumped 19%.**

Cost to care for Californians sees record inflation from 2019 to 2021

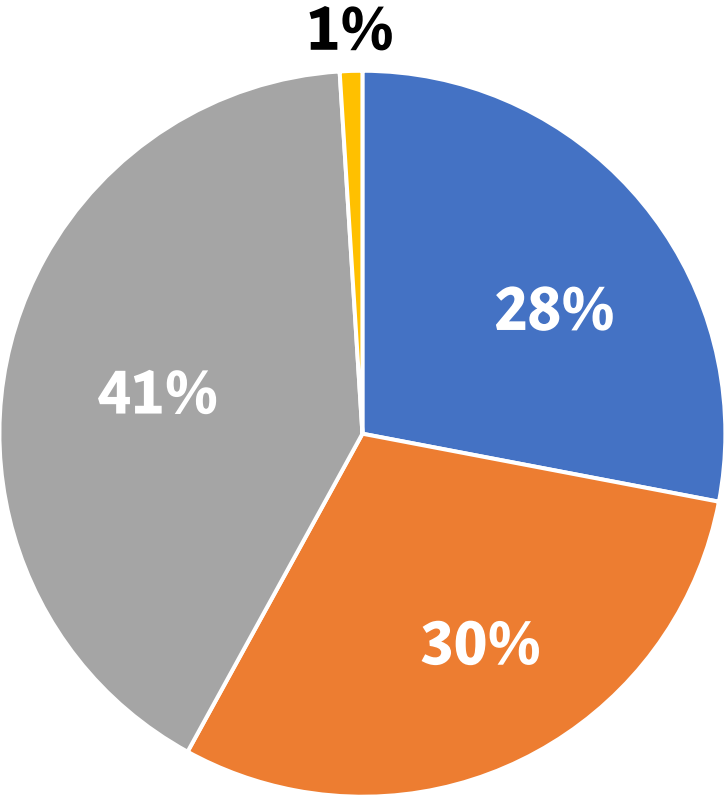


A Structural Problem with Health Care Funding

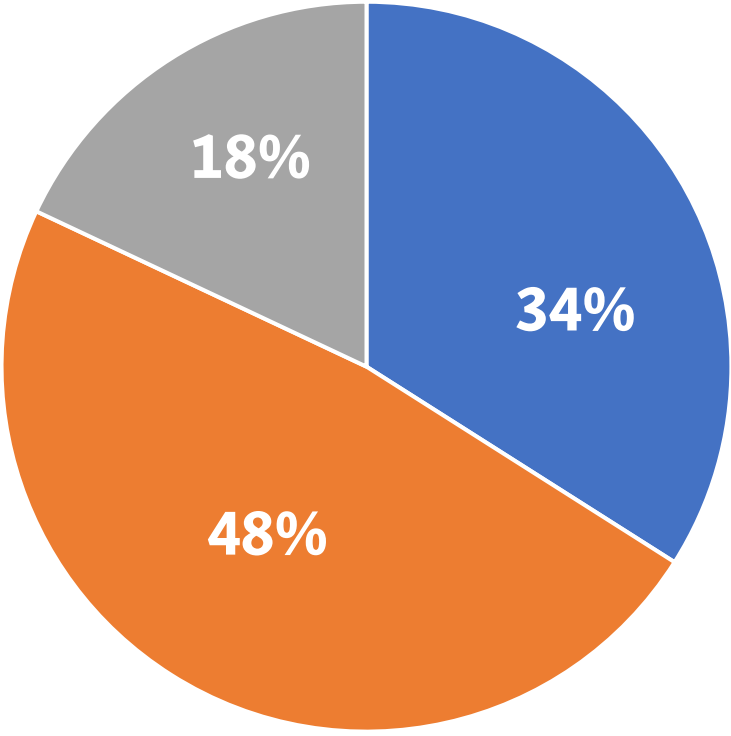
- The state of California pays hospitals **74 cents for each \$1 of care for Medi-Cal patients**
- The federal government pays hospitals **75 cents for each \$1 of care for Medicare patients**
- **73% of patients** in the average hospitals in California have Medicare or Medi-Cal
- Every day, **51% of hospitals** in California lose money providing care for patients.

The problems are complex, but solutions are within reach:



Improve state investment in Medi-Cal – to address systemic challenges for disadvantaged people and generate greater stability in resources for health care



Protect and enhance Medicare funding – to safeguard health care for seniors and stabilize a shaky foundation of health care resources for all



Enhance workforce investment – to build the pipeline of clinical professionals to support growing demand



Lower the cost of prescription drugs – to reduce a major expense that is beyond the control of hospitals and other health care providers
